PROCESS STAGE	POTENTIAL RISK	CONTROL MEASURES	ACTION REQUIRED
DELIVERY			
Packaged in 10 kg waterproof plastic tubs with peel-off, re-sealable lid. Tub incorporates metal-wire handle for carriage. Product is supplied in powder form.	Risk of spillage if the container is dropped. Risk of injury to user if dropped.	Trained employees should handle only single containers at any given time. Take care not to drop containers. Ensure that the cap is secure at all times.	Transfer containers to store immediately following delivery. Do not leave containers in areas where users of the building will come into contact with them.
STORAGE			
Containers must be stored upright in a cool, dry storage area. Product must be kept stored in its original container.	Risk of emission of toxic fumes if involved in a fire – product itself is not flammable. Minimal risk of spillage if lids are firmly in place. Lids are not child proof. Risk of Chlorine gas emission if heated.	Keep lid firmly on container. Ensure that the product is stored away from any flammable materials. Keep containers in secure storage areas. Restrict access to storage areas to authorised personnel.	Use oldest stock first. Make regular checks to ensure that containers are not damaged. Make regular checks to ensure that storage area is clean and tidy.
USAGE			
Product is dispensed with a measuring scoop directly into small, commercial dishwashing machines.	Risk of eye contact. Risk of skin contact. Risk of ingestion. Risk of inhalation.	Handle the containers with care. Wear Personal Protective Equipment. Ensure that the container is returned to the store when not in use. Always read the manufacturer's instructions prior to use. Ensure that the work area is well ventilated at all times. Ensure that any spillages are cleaned up immediately.	Provide employees with PPE as follows: <ul style="list-style-type: none"> Protective overall Chemical splash goggles or face shield Household rubber gloves Ensure that operatives are aware of location of First Aid facilities and personnel.
DISPOSAL			
Empty containers can be disposed of as normal waste. Residual stocks must be disposed of as hazardous waste and disposed of accordingly. Recycle all containers wherever facilities are available.	Small risk of skin or eye contact. Small risk of inhalation or ingestion. Risk of contamination with other substances.	Do not store any other material in the empty containers. Ensure that neat product does not come into contact with sewerage systems.	Ensure that all operatives wear Personal Protective Equipment at all times during disposal.
